The Department of Human Services (DHS) requests authorization to enter into a new contract with AT&T for the period of September 1, 2019 to June 30, 2022, in an amount of \$458,476 plus a 10% contingency for a total amount not to exceed \$504,322. The purpose of this contract is to provide BOX access licenses and cloud content management.

### Background

The Health Insurance Portability and Accountability Act (HIPAA) requires that covered entities implement safeguards to ensure the confidentiality, integrity, and availability of protected health information. Protected health information (PHI), under US law, is any information about the health status, provision of health care, or payment for health care that is created or collected by a covered entity that may be linked to a specific individual. While the Human Services Agency (HSA) may not be a covered entity under HIPAA, the Department of Public Health (DPH) is a HIPAA covered entity who routinely collects Protected Health Information (PHI) and works to

implement compliant data sharing between end users. Within this contract, the HSA, DPH and the Department of Homelessness and Supportive Housing (HSH), have combined their needs to procure BOX licenses and cloud content management at a more favorable cost. Typically, most non-service IT procurements are handled through purchasing and /or the City's Technology Marketplace and do not come through Commission. However, procurements involving Protected Health Information (PHI) must include a Business Associate Agreement (BAA), which in turn necessitates the use of a contract. A BAA is an appendix to a contract that includes conditions and contractor responsibilities to protect client data. Since the DPH requires cloud content management involving the maintenance, transmission, storage, and access of Protected Health Information (PHI), this purchase is facilitated through a departmental contract.

The HSA released a Request for Proposals in August 2018 for Cloud Content management, which AT&T was awarded. AT&T's proposal utilized the BOX application as their HIPAA compliant cloud storage vehicle. BOX is a HIPAA compliant cloud-based content-sharing solution that facilitates collaboration internally between staff and externally with agency partners. BOX enables users to store, share, and work with the latest versions of content in the cloud via most web-enabled devices.

Previously procured through the Technology Marketplace, the HSA, along with the Department of Public Health (DPH) and the Department of Homelessness and Supportive Housing (HSH), have each historically used BOX for the cloud storage of non-PHI data. The familiarity with the application will allow for a more seamless transition into PHI compliant storage administration and data sharing. It is anticipated that other city departments will piggyback the AT&T contract to procure BOX licenses and cloud content management for their respective departments through the work order of funds.

#### Selection

Contractor was selected through RFP 803, which was issued on August 31, 2018.
