#### **Board of Supervisor Visits**

Co-chair walked thru each district to determine if visits had been scheduled, if the leaders needed any additional support and to ensure that all members were empowered to bring the information and advocacy discussed to the Board of Supervisors within the next two months. The first visit will be tomorrow, January 14<sup>th</sup> and discussion about possibility of creating a list of FAQ's, depending on how the visits go.

### LTCCC Workgroups

• **Behavioral Health:** Susie gave an update on one of the recommendations that involved Metta funding for a Life Review (there are a range of models) group which is evidenced

based with the goal of reducing social isolation. Cathy gave an update, Felton is partnering with the Jewish Home to work on a pilot that came out of the Behavioral Health report recommendations, likely starting in April or May and will run for about four months.

• **Palliative Care:** Kelly provided an update, including a Learning Journey's project, which engaged a variety of cultural/ethnic groups citywide to ensure that the approach is culturally competent and will ensure that palliative care is available to all San Franciscan's. They will publish an academic paper on the findings. Additionally, the Stupeski Foundation is providing funding for Black, Latinx and Asian groups to allow for community based education and services, such as advanced care planning or caregiver support. Will likely be a 3-6 month project. They are also supporting the PC with capacity building including a part-time Executive Director position and developing a website.
