**Discussion:** Existing Remaining 4 domains

- Housing
  - There is affordable housing needs assessment which happens every year and every three (3) years. The assessment that happens yearly is snap shot in time of what affordable housing there are for older adults and adults with disabilities and what is currently in the pipeline.
  - The 2022 Affordable Housing Needs Assessment report—the City's first—will be released in October. The report will be based on community input from a citywide survey, community forums, focus groups, and in-depth interviews, as well as on population and service data.
  - The Needs Assessment is conducted in partnership with the Mayor's Office on Housing and Community Development (MOHCD), the Mayor's Office on Disability (MOD), the Department of Homelessness and Supportive Housing (HSH), and the SFHSA Planning Department

(Although DAS conducts the Needs Assessment), SFHSA does not provide housing.

- Assisted living facilities waver is to allow facilities to have beds that Medicare will pay for.
- Housing element looking at varies plans for housing
- Supportive housing work; DAS is currently assisting in living facilities waivers and permeant assistance in housing living
