## 14A. CLF 6 Month Report (Presented by Fanny Lapitan) – INFORMATION ONLY

CLF provides support for adult San Francisco residents so they can live in the community with support. CLF services individuals through public guardians, Brilliant Corners who provide housing. They received 109 new referrals and helped over 62% of these people.

Presenter Zaugg is requesting authorization to modify the existing grant agreement with La Raza Centro Legal for the provision of Legal Services for Older Adults program; for the period of October 1, 2022 to June 30, 2024, in the additional amount of \$323,458 plus a 10% contingency for a revised total amount not to exceed \$902,686. Presenter Hofverberg is requesting authorization to modify the existing grant agreements with multiple providers for the provision of Aging & Disability Resource Center (ADRC) program; for the period of October 1, 2022 to June 30, 2024, in the additional amount of \$381,308 plus a 10% contingency for a revised total amount not to exceed \$2,463,057. This is to increase the language capacity at three Aging and Disability Resource Centers.

Commissioner Jung was pleased to see grant funding for bilingual staff to serve non-English speaking clients.

Commissioner Lum asked if there are any guidelines for hiring additional linguistics, presenter Hofverberg said there are no real guidelines but more from actual needs from clients and ADRC's. Commissioner Lum was disappointed by a lack of specific guidelines and presenter Hofverberg stated they do look at the data for the need of funding, it is evaluated.

President Knutzen commented that data is kept on seniors who utilize services at the centers to confirm language needs.
