Dignity Fund Overview What is the Dignity Fund?

 Revenue stream to support eligible services for seniors and adults with disabilities



Dignity Fund Overview History of Proposition I

• Dignity Fund Coalition

Representatives from over 50 community-based organizations and advocates

- Proposition I (November 2016 election)
 - Passed with 67% of vote
 - Introduced by Supervisor Malia Cohen (D10) and supported by 8 other BOS members and Mayor Lee
 - Implementation ordinance sponsors: Supervisor
 Cohen and Supervisor Norman Yee (D7)

Dignity Fund Overview Main Prop I Components

- Creates special fund ("Dignity Fund")
 - Requires City contribution (\$38M baseline to grow by \$33M over next 10 years)
 - Allows unspent funding to roll into following year
- Establishes planning and allocation process
 - Including Community Needs Assessment and Service and Allocation Plan
- Creates Oversight and Advisory Committee

Dignity Fund Overview Eligible and Ineligible Services

Eligible Services

- Access (including but not limited to Empowerment, Advocacy, and Education)
- Caregiver Support
- Case Management and Care Coordination
- Connection and Engagement
- Housing Support (with limitations)
- Nutrition & Wellness
- Self-Care & Safety

+ Staff to support Dignity Fund administration

*See legislation for comprehensive list

Ineligible Services

- Services mandated by state or federal law
- Services that benefit seniors/adults with disabilities incidentally
- Medical health services (some exceptions) and those provided by hospital or long-term care facility
- Capital expenditures (some exceptions)
- Acquisition of property or capital expenditures for construction o housing

Dignity Fund Overview OAC Role & Responsibility

- Advisory body to the Department of Aging and Adult Services (DAAS)
- Provide input into:
 - Community Needs Assessment (CNA)
 - Services and Allocation Plan (SAP)
- Review the annual data and evaluation report
- Establish and maintain a Service Providers Working Group
- Meet at least 6 times per year

Dignity Fund Overview OAC Role & Responsibility

- Tasked to develop recommendations for DAAS regarding:
 - Outcome objectives for services;
 - Evaluation of services;
 - Common data systems;
 - \circ Process for making funding decisions;
 - Program improvement and capacity –building;
 - Community engagement in planning and evaluating services;
 - \circ Leveraging dollars of the Fund; and
 - $\,\circ\,$ Use of Fund as a catalyst for innovation.
