BACKGROUND

The Department of Aging and Adult Services (DAAS) is reporting a first amendment to the California Department of Aging's Health Insurance Counseling and Advocacy Program ("HICAP") contract (HI-1718-06) and associated budget for your informational review. The State has informed DAAS of *reductions* in funding to this contract due to reduced Federal funding.

BUDGET DETAIL

The term of HICAP contract HI-1718-06 runs from July 1, 2017 to June 30, 2020. The original maximum value of the contract was \$984,984. Amendment One states a funding reduction in all three contract years, for a total reduction of \$50,432. Reductions are taken as follows: a \$12,997 reduction in the current fiscal year (ending June 30, 2018), a \$19,322 reduction in FY 18/19, and an \$18,113 reduction in FY19/20. Revised maximum value of the contract is now \$934,552. Detailed information as to reductions by year is attached on the CDA Exhibit B – Budget Display document.

Unless supplemental funds are located, corresponding reductions in annual DAAS budget for HICAP programming will be made. The HICAP program is currently contracted through Self-Help for the Elderly for delivery of services.
