## Disabilities and Access and Functional Needs (DAFN) Workgroup

- •DEM and MOD established the Disabilities and Access and Functional Needs (DAFN) Coordination Workgroup in March 2017.
- •DAFN is focusing on how it serves the AFN community in:
  - Emergency communications;
  - Emergency transportation;
  - Emergency evacuations; and
  - Emergency sheltering.
- The DAFN Coordination Workgroup meets every other month in January, March, May, July, September and November.
- •Workgroup consists of both CCSF agencies and NGO/CBOs.

### The DAFN Population

Individuals who have:

- Developmental, intellectual, physical or sensory disabilities;
- •Chronic conditions or injuries;
- •Limited English proficiency or non-English speaking.



#### Individuals who are:

- •Older adults, children, or pregnant;
- •Living in institutional settings;
- •Low-income, homeless, and/or transportation disadvantaged; or
- •From diverse cultures.



### 2017 DAFN Workgroup Efforts

- Emergency Preparedness Final CMS Rule for Medicare and Medicaid providers.
- ✓ Overview of Paratransit Operations
- Discussion of DAFN lessons learned from significant local emergency events in 2017, including SF extreme heat and North Bay Fires.
- ✓ Mapping of DAFN resources and facilities throughout CCSF.

- ✓ Identification of DAFN demographics by BOS District (DAAS's 2016 Needs Assessment)
- ✓ Increased engagement with DAFN support agencies (e.g. Lighthouse for the Blind).
- ✓ Inclusion of Disability Organizations in emergency preparedness/response training and exercises (e.g., SF Ballpark evacuation, Yellow Command sheltering).

## 2018 – 2020 DAFN Workgroup Efforts

The DAFN Workgroup identified these action items as high priority for 2018-2020:

- Updating processes and procedures for Durable Medical Equipment (DME) access and transport during and following an emergency incident.
- Continued engagement with SF Fire Department, the Department of Building Inspection and others on policies and procedures pertaining to safe and effective DAFN evacuation, especially in multi-story buildings.
- Mapping and sharing of DAFN facilities and resources throughout San Francisco to AFN populations, and especially Deaf and Hard of Hearing and Blind and low-vision individuals.
- Implementation of recommendations from the Aging and Disability Friendly Task Force Emergency Preparedness and Resilience Domain.

### 2018-2020 Resiliency & Emergency Preparedness Recommendations

1. Provide support and training for seniors, people with disabilities, and caregivers on emergency preparedness;

- 2. Prioritize outreach campaign to encourage registration with AlertSF; and
- 3. Ensure a strategy for evacuating people with mobility challenges in multi-story buildings.

Dept. of Public Health, Dept. of Emergency Management, Mayor's Office on Disability, Dept. of Aging and Adult Services, Neighborhood Empowerment Network

### SB 1376: Transportation Network Companies (TNC) Accessibility for All Act

- Signed by Governor Brown September 2018
- For Statewide implementation by 2024

#### Accessible Business Entrance (ABE) Ordinance

- Currently in first of four phases
- To be implemented in SF over the next three years

#### Litter and Waste Reduction "Plastic Straw" Ordinance

- Discussion of exemption for people with disabilities
- ➢ For SF implementation in 2019

#### SF Emerging Technology Recommendations

- Currently in Workgroup phase
- To be presented by City Administrator to BOS December 2019
- Has track recommendations related to Accessibility & Safety, Equitable Benefits, and others
