The Department of Disability and Aging Services (DAS) requests authorization to modify the grant agreements with non-profit service providers for the period of January 1, 2024 through June 30, 2025, in an amount of \$191,963, plus a 10% contingency for a total amount not to exceed \$13,798,585. The purpose of these modifications is to add funding for the FY23-24 Cost of Doing Business (CODB) adjustment and to revise the grant contingency amounts.

#### Background

The City is providing a 3.75% Cost of Doing Business (CODB) adjustment for General Fund contracts and grants with nonprofit organizations for FY 23-24. The CODB adjustment is provided to help compensate the non-profit service providers for the increased costs associated with providing services on behalf of the department.

## **Eligible Costs**

The CODB funds will be applied to the following costs contained in the budgets of each Grant Agreement:

- Salaries and associated benefits
- Operational costs excluding direct client assistance dollars, capital equipment, or capital improvement costs funded by the department.
- Indirect costs
- General funds and leveraged state and federal funds.

The CODB will not be applied to pass-through funds, new programs, or add-backs that started this fiscal year.

#### **Grant Modifications**

Most grant agreements contained enough contingency in the existing not to exceed amounts to cover the FY23-24 CODB increase and therefore did not require formal commission approval. For those grants, the contracts unit will work with grantees to process informal budget revisions to add the CODB funds.

The grant agreements that did not contain enough contingency in the existing agreements are included in this memo and are listed in Table 1 below. The table shows current grant amounts, the CODB amounts being added, the revised annual amounts, contingency amounts, and not to exceed amounts. For these grant agreements, upon commission approval, the contracts unit will process formal grant modifications based on the amounts in Table 1 in order to have enough contract authority to add the CODB funds.

## Funding

This CODB increase will be funded by County General Funds.
