### **DEPARTMENT OVERVIEW**

The mission of the Mayor's Office on Disability is to ensure that every program, service, benefit, activity and facility operated or funded by the City is fully accessible to, and useable by, people with disabilities. MOD is responsible for overseeing the implementation and local enforcement of the City's obligations under the Americans with Disabilities Act (ADA) as well as other federal, state and local access codes and disability rights laws. As part of this responsibility, MOD may issue policies and procedures for Board of Supervisor approval, and engage directly with Board-proposed legislation or resolutions impacting people with disabilities.

State and local governments have an obligation under Title II of the ADA to remove architectural barriers at their buildings and facilities, maintain accessible features, and provide program access to all City and City funded programs. As the City's overall ADA Coordinator, MOD oversees this obligation via San Francisco's ADA Transition Plan, and related-ongoing, dynamic self-assessment and programmatic action plans. These Plans are intended to mitigate barriers in City-owned and leased facilities and reduce programmatic barriers to city services and civic engagement. As required under adoption of the Transition Plan by the Board of Supervisors in 2007, the Plan and its processes undergo periodic architectural and programmatic assessment.

MOD also oversees the Citywide ADA grievance procedure, and serves as technical accessibility advisors to City Departments, the Board of Supervisors and the Mayor. MOD works closely with departmental ADA Coordinators, whose assignments include but are not limited to coordinating accessible programs and services, handling requests for auxiliary aids, providing effective communication and receiving complaints from the public and working to resolve them.

### **KEY PROGRAMS AND SERVICES**

### Architectural Access

- Project management and oversight of the City's ADA Transition Plan and barrier removal obligations.
- Citywide technical assistance regarding architectural accessibility obligations, including field review, as needed.
- Advises the Capital Planning Committee on prioritization of capital fund allocations to support and advance accessibility.

### **Programmatic Access**

- Oversees citywide ADA Grievance Procedure and related training and guidance for Departmental ADA Coordinators.
- Technical assistance and service referrals including public information, outreach, and education.
- · Program policy development and legislative initiatives oversight

### **Digital Access and Inclusion**

- Advises the City's Committee on Information Technology on the Digital Accessibility and Inclusion Standard (DAIS) to
  ensure that City departments provide equitable access to city digital content, and to support the City's effort to comply
  with U.S. Department of Justice ("DOJ") Web Content Accessibility Guidelines by the April 2026 deadline.
- Reviews City department requests for an exception to the Web Content Accessibility Guidelines consistent with DOJ guidelines.

### **Disaster Planning for People with Disabilities**

- Supports and advises on emergency efforts and strategic planning related to disability access, including but not limited to:
  - Evacuation planning
  - Sheltering Sites
  - General Disaster Planning (e.g. earthquake, tsunami, fire, etc.)

### Mayor's Disability Council

- Public body that advises the Mayor and the Board of Supervisors on disability issues, 11 seats with two year terms
- Works with the Mayor's Office on Disability to prioritize ADA compliance
- Provides a public forum to discuss disability issues
