**WELCOME & INTRODUCTIONS** – Co-chair Kelly Dearman, Executive Director of DAS and Cochair Eileen Norman, Executive Director of IHSS Public Authority, facilitated introductions of meeting participants popcorn style.

#### PRESENTATION: ADF WORKPLAN OVERVIEW

**Presenter:** Maceo Persson from the Office of Community Partnerships shared a presentation about ADF's current progress in the action plan and upcoming plans for 2025.

#### Updates:

- Digital Equity Domain:
  - A \$12 million grant for SF Tech Needs Assessment and greater Bay Area is in progress. There is a new grant opportunity in the Department of Technology in Sacramento. DAS should look into this, there is a department policy already in place.
  - The City Digital Equity and Inclusion Standards Advocacy Committee's goal of extending accessibility policies to technology is still in progress. A better infrastructure is needed to understand and implement accessibility requirements. These policies will apply to city employees, businesses that make/sell technology to the city, and nonprofits.   - Transportation Domain:
    - SFMTA published a Needs Report for community feedback via online and in-person. It is open until December 13<sup>th</sup>. Implementation will begin in Summer 2025. SFMTA is asking ADF to help push out survey. - Engagement & Inclusion Domain:

- The city-wide campaign of anti-ableism has added "A" for "accessibility" to all DEI projects. For instance, HSA has a DEIBA office now. Hoping other departments follow.
- MOD is working with the Department of Human Resources to incorporate a mandatory anti-ablism training for CCSF employees. This training was developed by the former Director of MOD, Nicole Bond, and will be available online.
- To improve the commission's representation of people with disabilities, Maceo Persson will work with MOD to identify potential candidates.

## DISCUSSION: CREATING THE ADF WORKPLAN

**Presenter:** Maceo Persson, Project Manager of the Office of Community Partnerships, reviewed strategies of past ADF workplans and discussed ways to create the 2026-29 ADF Workplan.

**Discussion:** The group reflected on past workplans which consisted of SWAT analysis, departmental/expert insight as well as community conversations. Suggestions were made to include more input from communities and other various stakeholders. If ADF conducts a comprehensive SWAT analysis/needs assessments a smaller group is preferred. Whereas, if ADF continues a work plan, then a larger group works better because of shared experience. ADF invites any valuable people to this work group.

Discussion Questions included:

- $\circ$  Who do we want to hear from for the third ADF Workplan?
- From these conversations, what strategies drove the most engagement?
- Will this be an advisory board structure? Previous cycle's structure? Formality?
- Do we include representation from the SFUSD Special Education Community Advisory Committee (Parents)?
