DFCNA Project Overview

Purpose

- Gather community input on the needs of diverse older adults, adults with disabilities, veterans, and caregivers
- Develop a better understanding of community needs, service system strengths and gaps, and equity issues
- Use findings to inform Dignity Fund spending to address community needs

Overview of the Dignity Fund Cycle for FY 2027-28 to FY 2030-31





Research Questions

- What are the needs of older adults and adults with disabilities?
- What are system-level strengths and gaps?
- What population subgroups may be underserved?



Key Components: Community Research

Gather input about community needs directly from diverse stakeholders using qualitative and quantitative research methods

- Community forums
- Focus groups
- Population survey
- DF Service Provider Work Group listening session



Key Components: Equity Analysis

Evaluate how well DAS is serving the city's diverse populations, using population and program administrative data

Equity Factors

Low-to- Moderate Income Proficiency	Living Alone	Communities of Color	LGBTQ+
--	--------------	-------------------------	--------

Equity Analysis questions:

- 1. Are populations with the presence of an equity factor utilizing services at the same rate as the population citywide?
- 2. How do service utilization rates among low-to-moderate-income populations compare across districts in the city?
- 3. How are funds spent across city districts?



Key Components: Gaps Analysis & Recommendations

Synthesize findings from community research and equity analysis to answer DFCNA research questions and develop recommendations to address areas of need

- Gaps analysis findings
- Recommendations





Lessons Learned from Past DFCNAs

Lessons Learned

Project timeline and approach

- Begin consultant procurement earlier (~Jan 2025)
- Conduct community research Jul-Sept; complete data collection by October
- Bring select analytical activities in-house (e.g., equity and gaps analyses, writing)

Community outreach and engagement

- Strengthen general outreach activities with support from SFHSA Communications
- Collaborate with DAS network for general and focused outreach, particularly for adults with disabilities and equity populations
- Continue to provide virtual options for participation (+ tech assistance)

Community research activities

- Coordinate with DAS network to achieve participation targets for focus groups
- Simplify and shorten survey





2025-26 DFCNA Project Plan

Project Approach

- SFHSA Planning:
 - Project manage DFCNA, including directing consultant work on community research
 - Facilitate development of gaps analysis findings and recommendations
 - Prepare full DFCNA report and related presentations
- DAS OCP:
 - Coordinate community research engagement/participant recruitment via City and community partners
 - Support in-person and virtual community research events + survey administration
