Housing

- Reference and implement the recommendations from the collaborative housing report developed by MOHCD, DAS, and ODA.

Outdoor Spaces & Buildings

- Complete Hallidie Plaza renovations to meet accessibility standards.
- Ensure input from the disability and older adult communities is incorporated into the Sunset Dunes project. Implement accessibility features such as 27-inch tall toilets, fold-down grab bars, and stations for assistive technologies.

Transportation & Mobility

- Review and enhance MTA's accessibility and disability inclusion trainings.
- Support a study and review of the wheelchair repair program to advocate for enhanced programming.

Communication, Information & Technology

- Implement the SF Tech Council's program to train community members in using digital health portals, including San Francisco Health Network applications.
- Collaborate with DPH to identify and resolve accessibility barriers in the Epic system.

Engagement & Inclusion

- Establish a Disability Cultural District.
- Create a centralized community calendar to improve event access and coordination.
- Develop an ADF Action Plan to support ADF in having an official advocacy voice.

Community Supports & Health Services

- Creating an anti-ableism training for medical providers.
